





### 1. Preamble

- 1.1 The **EXN X50 SERIES** is a championship that is run on the Assetto Corsa platform on PC.
- 1.2 The vehicle used will be selected by the organizers:
  - X50 Tuned Cup
- 1.2 Only the **top 20 competitors** will participate in the championship.
- 1.3 The race will be organized and broadcast by Adrenaline Impact (Organizer).
- 1.4 The competitors will first be required to enter time trial sessions (Series Qualifying) in order to qualify for the main event.
- 1.5 This championship is open to Malaysians and Foreigners with a valid permit residing in Malaysia.

### 3. Calendar

- 3.1 The Pre-qualifying session will be held from 23<sup>rd</sup> May to 29<sup>th</sup> May 2022, at the Okayama Circuit, Japan. The fastest time will determine the qualifying results for the final races as per regulation 4.3.
- 3.2 The final championship races will be held as follows:
  - Round 1 Paris Street Race, France 5<sup>th</sup> June, 2022
  - Round 2 Kyalami, South Africa 12th June, 2022
  - Round 3 Hungaroring GP, Hungary 19th June, 2022
  - Round 4 Suzuka GP, Japan (90min endurance) 26<sup>th</sup> June 2022







#### 4. Event Format

- 4.1 The Championship will be held over 4 races, with a points system used to determine the results of the championship as per Appendix 1.
- 4.2 Drivers are required to use the **skins** supplied with the mods.
- 4.3 Pre-qualifying will be used to determine the final entries into the main event.

  The results of pre-qualifying will be based on the **best lap time overall**.
- 4.4 The race practice will have a duration of 1h and will be held directly before the qualifying session.
- 4.5 The race grid will be set by a 20 minute qualifying session directly before the race.
- 4.6 The race will utilize a standing start procedure and it will have a duration of 45mins, except for round 4 which will last 90 minutes.

# 5. Eligibility

- 5.1 The Event will be open to competitors over 18 years of age with MALAYSIAN citizenship or persons currently legally residing in MALAYSIA.
- 5.2 Participants under the age of 18 may be allowed to compete, subject to the discretion of the Organizer upon getting in contact with a parental approval.
- 5.3 The participant name in Assetto Corsa must follow this exact format: Full name + Surname (ie. Lewis Hamilton). No nicknames or incomplete names allowed, failure to do so will results in DISQUALFICATION from the series).
- 5.4 The participant's registered FULL NAME must be the same as the driver name in Assetto Corsa. Non compliance will forfeit your entry in to the series.
- 5.5 The Organizer reserves the right to remove anyone from the event due to non-compliance of the Regulations.
- 5.6 The Competitors must comply to the regulations contained in the entirety of this document.
- 5.7 Any discriminatory or offending actions, words, posts or contents are forbidden and can lead to permanent exclusion. These include any action, words, posts or contents that brings disrepute to the competition and/or







- organizer and/or sponsor/partner inclusive of any public forum including social media.
- 5.8 Any discriminatory or offending actions, words, posts or contents from third parties shown to have a relationship with a participant may be construed as coming from the participant and may also result in exclusion.
- 5.9 Competitors must attend the **compulsory briefing** in the relevant Discord channel, failure to do so **may result in disqualification**.
- 5.10 Qualified drivers must join the participants Discord server in order to receive event related private information. Said participant Discord server can be found at the link below: http://www.adrenalineimpact.com/discord.
- 5.11 This event will be stewarded by a panel of professional stewards that will impose penalties as needed after every race. All decisions are final and non-appealable.
- 5.12 Track cuts will be managed by the server itself and will impose drive through penalties to those that exceed the limit per race (2 cut track per race).

### 6. Penalties

- 6.1 There will be a penalty in the form of a drive through the pitlane without stopping (Drive Through Penalty) for drivers that have cut the track. There will be two warnings issued before the penalty is enforced.
- 6.2 There will be a penalty in the form of "time added" for those who have had heavy contact with another competitor during the course of the race. This penalties will be applied AFTER the race and therefore there will be a provisional result table as the race finishes and the Final Official Results will be announced in our discord within 24h of the race end.
- 6.3 Cut Track Penalties will be administered automatically via the race control server without outside interference by the Organizers, however the Organizers reserve the right to adjust the penalty system should the need arise.
- 6.4 Participants will have to serve their penalties within 2 full laps after the incident.
- 6.5 Should the competitor be unable to serve the Drive Through Penalty before the end of the race, an equivalent time penalty will be given instead.







# 7. Prizepool Allocation

7.1 The Prizepool for this event will consists of Works Engineering Vouchers as well as a real life driving experience at Sepang Circuit in the Neves 1600 all under the supervision of InterFormula as associated partners.

# **APPENDIX 1**

# **POINTS SYSTEM**

The points system will be applied to the results after all penalties are calculated. The points system is at follows:-

Position	Points
1 <sup>st</sup>	10
2 <sup>nd</sup>	8
3 <sup>rd</sup>	6
4 <sup>th</sup>	5
5 <sup>th</sup>	4
6 <sup>th</sup>	3
7 <sup>th</sup>	2
8 <sup>th</sup>	1

The final championship position will be determined by the cumulative points gained by each competitor, with the most cumulative points being the Champion.







#### **APPENDIX 2**

# **Prize Test Session**

- 1. The prize shall consist of a test session run by Inter Formula using the Neves 7 race car, which normally competes in the Asian Classic Car Challenge SL7 class, at the Sepang International Circuit.
- 2. The provisional date of the test shall be in Mid July, during pre race tests for the Malaysian Championship Series. Exact dates will be announced in due course.
- 3. The objective of the test is to evaluate both car and driver, as per a regular test session, so the driver will be participating in all aspects of the test session. The team will debrief and evaluate the performance of both car and driver, as is standard practice within the industry.
- 4. The driver will be required to follow the programme laid out by the team. Failure to comply with team instructions can lead to termination of the test.
- 5. There will be no guarantee of time or distance travelled during the test due to external circumstances, red flags, conditions etc.
- 6. The schedule of the test will be made known to the driver in due course, however schedules may change during the course of the day.
- 7. The driver will have to ensure that they are in good physical condition in order to take part in the test session, and they will have to sign a waiver form in order to proceed.
- 8. If the winner of the prize is unable to proceed with the test session, the team and the organizers have the right to reassign, withdraw or cancel the test session as they see fit.
- 9. Drivers who have been afforded the opportunity to participate in the test will be required to read, agree and sign an indemnity form, the text of which is reprinted below.
- 10. The Track Day will be recorded by Adrenaline Impact in order to produce marketing and promotional material afterwards. By participating you agree that the Organizers can make and broadcast photographs and movie recordings (e.g. internet stream), on which the winners and participants are identifiable as well as statements, interviews and similar captured on audio and video. The Organizers hold the rights to these recordings to use for promotional and marketing purposes.







### **Prize Test Session Indemnity**

This executed Agreement confirms that DRIVER understands and acknowledges that the use or operation of a race car, including the RACE CAR, and automobile racing.

DRIVER agrees his estate shall likewise indemnify, release, hold harmless and defend the Indemnified Parties from any lawsuits, actions, demands, liability, penalty, cost or expense, of whatsoever nature or description, arising out of DRIVER's use or operation of the RACE CAR or any activities hereunder, of whatsoever nature or description, from DRIVER's family, including but not limited to, any relatives, spouse, children or significant others, and the claims of any other third party, provided any such lawsuit, action, demand, liability, penalty, cost or expense does not arise out of the negligence of the Indemnified Parties.
